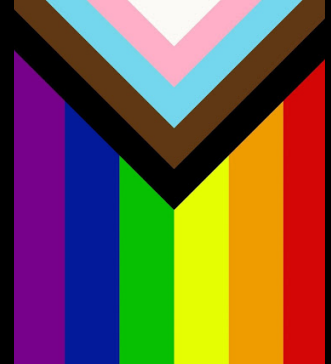

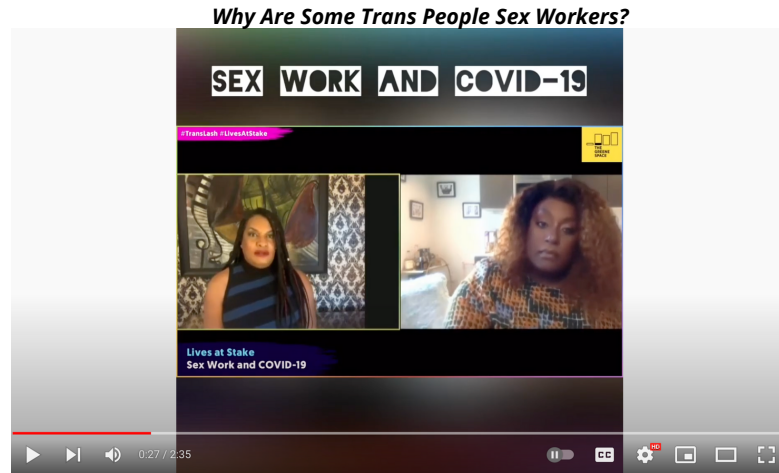
# At The Intersections

## The Conditions Of LGBTQ+ Sex Workers

Decriminalization of sex work does not mean the decriminalization of human trafficking says Jillian Modzeleski - Senior Attorney in Charge of Human Trafficking Intervention. Many trans women in the U.S. engage in sex work. Whether it is for survival or not, decriminalization is essential to protecting their rights.

### The Homophobia and Transphobia Experienced by LGBTQ Sex Workers

Included is an article by The Global Network of Sex Work Projects and a video by WUSA 9 News. They both expose the conditions that trans sex workers are forced to work under. The brief, linked above, conducts a study around the treatment of trans sex workers around the world. The video, linked on the left, is a first hand account to the lived realities of trans sex workers in the U.S.. When these women face these conditions; with an increased chance of sexual assault and murder, the reality is their rights and lives are not protected in the ways they deserve.

### To Protect Black Trans Lives, Decriminalize Sex Work

Included is an article by ACLU and a video by DECRIMNOW DC. Kaniya Walker, in the article linked above, draws from her experience and many others that they "cannot survive and thrive if our lives are policed and criminalized." The video, linked to the right, argues that the criminalization of sex work further increases the violence towards Black and brown transgender woman. The organization pushes for decriminalization not only to protect trans women, but to decrease the amount of sex trafficking in the U.S..
