The Stonewall Riots The Stonewall Riots began on June 28, 1969, when New York City police raided the Stonewall Inn, a gay bar in Greenwich Village. This raid sparked six days of protests and violent clashes. The riots became a catalyst for the global gay rights movement.

Investigating healthcare experiences across the lifespan among older LGBT and transgender & gender diverse adults

"The lesbian, gay, bisexual, transgender, and queer (LGBTQ) communities have made significant strides in garnering the right to lead a life free of prejudice and stigmatization in the last 50 years (Kunzel, 2018). In prior decades, discriminatory laws and policies against individuals who identify as LGBTQ permeated throughout institutions, including the U.S. healthcare system. People identifying as transgender and gender diverse (TG/GD) are currently the target of attacks, with their right to receive gender-affirming care being threatened or banned in many states (Kindy, 2023). The current study explored the experiences of older LGBT adults..."

The Impact of Anti-DEI Legislation on **LGBTQ+ Faculty in Higher Education**

"Teaching and research on LGBTQ+ and diversity-related issues has become increasingly challenging amidst the anti-diversity, equity, and inclusion (DEI) legislation that is advancing across the U.S. As of spring 2024, nine states have passed anti-DEI legislation related to higher education. Currently, at least 20 other states are considering such legislation. Many of the same states are seeing a rapid expansion of anti-LGBTQ+ legislation as well, including legislation restricting genderaffirming care for youth, prohibiting discussion of LGBTQ+ topics in secondary education, and allowing health care providers to discriminate based on moral or religious convictions..."
